Veterans' Preference The Veteran's Preference Law, 51 Pa.C.S.A. §7101 et. seq., requires applicants to be qualified for a job before they earn the preference. Veterans are required to verify their service by filling in the application section on military information and submitting an original DD-214 to prove military service and honorable discharge. Veterans' preference provisions are codified at Title 51 of the Pennsylvania Consolidated Statutes, Sections 7101-7109, and apply to all municipalities for both civil service and non-civil service employment. Veterans receiving an honorable discharge, the spouses of disabled veterans and qualified widows or widowers of veterans are entitled to certain preferences in hiring. The Pennsylvania Supreme Court has determined that veterans' preference for purposes of promotion is unconstitutional. If the veteran is among the top three available candidates on an employment certification, they receive mandatory preference in appointment over nonveterans. Pennsylvania courts have held, however, that employers may deny employment to a veteran who does not have the level of expertise demanded for the position.
