ENGINEER'S REPORT

Steve Holland: HOP – On a motion by Vernon Walter (2nd, Joe Claar), the Supervisors approved Steve Holland's Highway Occupancy Permit for his driveway at 175 Packard Street, Claysburg.

James & Rhea Acker Lot Line Change – Tabled; Easement need to be placed on plans & both property owners' signatures on plans.

Packard Street Condos – No update since May 2nd extension letter.

Jarrett Musselman –No action needed. Received surety letter last month. He needs ENS approval before Development Agreement can be executed.

Capital Telecom – No action needed. Surety letter was received. Need to post surety & will not need Developers Agreement due to the size of the project.

Marasco Park – Paving is complete; past Central States there is a slight bump on the road. Township will monitor the bump. Penelec has not completed their work.

Central States – Letter of Credit expires June 30th.

Sheetz Distribution Center – Dan Bennett, Sheetz Distribution Center Engineer & Facilities Manager, came to the meeting to find out the process to have a 4-way stop sign placed on Sheetz Way to assist with the anticipated increased volume of staff at the new corporate office that will open in about a year. Also, he would like a duck crossing sign on Sheetz Way. In order to authorize a permanent 4-way stop sign, a study will need to be done. All PennDOT and federal regulations will need to be met for sign placement, size & purpose. Eric Casanave provided Dan with a packet of information.

CDBG ADA project at Township Building – Eric updated the Supervisors that Trina Illnig asked him to review bond and assurances for bid proposal.

Township Tour after Rain Storm – Eric Casanave updated the Supervisors on a 6/2/2017 tour he had of several locations affected by a recent rain storm.

- 1. Locust Street/Milby Property Mr. Milby has erected two (2) trailers that are causing flow activity. Eric saw a report and video of water flowing across the street. This is an example of offsite improvement that has caused stormwater to impact township property and even downstream properties. Jordan mentioned the driveway is being used without an HOP at this location. HOP was denied for sight distance. Joe requested Arlene contact the Solicitor regarding this HOP matter. Since tour on 6/2/17, dirt has been added to build up the front yard which is going to cause more water issues per Matt.
- 2. <u>Intersection of Evergreen Road & Rose Lane</u> Heavy rains are causing some problems. Eric recommends cleaning out ditch & trim vegetation at Roudabush's Market. Also, he recommends to stay away from cat tails.
- 3. <u>Hilltop Road</u> Private property has a steep driveway with a curve. Debris washes off and onto township road. Driveway is not compliant with township ordinance. Eric recommends tightening and enforcing permits. Residence get a permit but do other work not on permit. Also, he recommends contacting the township Solicitor regarding what can be done with a private property that affects township roads, township right-of-ways, as well as damage township roads.

ROAD MASTER REPORT

Matt reported mowing and weeding continued, as well as grading the roads. Clean Up Day totals are as follows: 11.61 tons of tires; 16.26 tons for landfill; 43,260 lbs. of scrap metal. Matt is going to have PennDOT's Municipal Services look at Church Street, Park Road and Champion Road for blacktop paving this summer.

POLICE REPORT

Corporal Rich Brant gave the Police Report (attached). There was a discussion regarding the police and coverage in the township especially during summer holidays. *Liz Hoffman* said there are more traumas over the summer and police help the First Responders with traffic control. *Vernon Walter* asked Rich about the responsibly of missed calls (35 missed calls of 88 calls). *Bill Lightner* asked why Tyler Grigg was hired part-time and not full time. *Roger Lingenfelter* stated he is concerned no officer is in the township when officers are in court. *Scott Eicher* described an incident where family and neighbors fought while fireman tried to help a victim. Since no officer was on duty in township, they had to wait 35 minutes for State Police assistance. Also, the CVF went on this call since there no officer on duty in the township. *Jim Acker* stated he was surprised there is only one officer in the township. He felt he paid enough taxes for additional officers.

On a motion by Joe Claar (2nd, Vernon Walter), the Supervisors extend offer of a full time position to Tyler Grigg with the provision to finish his probation from before. At the completion of the probation, he will be paid at a First Officer hourly rate.
