

**Greenfield Township Supervisors
Regular Meeting
May 1, 2018**

The regular meeting of the Board of Supervisors of Greenfield Township was called to order by Chairman Treon at 7:32 p.m. The meeting opened with the pledge of allegiance.

Approval of Meeting Minutes: On a motion by Ray Benton (2nd, Jordan Oldham), the Supervisors approved April 3, 2018, Regular Meeting minutes as presented.

Scott Eicher discussed with the Supervisors the problem with false alarms in the area.

Grace Helsel complimented and thanked the Highway Department for the Community Clean Up Day.

Police Report

Grace Helsel said the part-time officers are under the impression they will have a full-time classification. At Freedom Township meeting, it was stated seasoned officers were not available. You have a seasoned officer; why not make him full-time?
