At the Greenfield Township municipal building, the special meeting of the Board of Supervisors of Greenfield Township, Blair County, was called to order by Supervisor Matt Treon at 12:30 p.m. The meeting opened with the pledge of allegiance.

**Highway Maintenance Department—Staffing:** On a motion by Matt Treon (2<sup>nd</sup>, Jordan Oldham), the Supervisors hired Clint Rosentrater as a part-time, on-call as needed, Highway Maintenance Laborer/CDL at \$13 per hour with no benefits.

**Police Department—Staffing:** On a motion by Matt Treon (2<sup>nd</sup>, Joe Claar), the Supervisors hired Daniel Eastep as a Full-time Probationary Officer pending a successful physical and psychological evaluation at \$17 per hour with one-year probation per the Collective Bargaining Agreement.


