Supervisor Oldham asked about police staffing, and the Chief replied he didn't want to rush into hiring and requested the Supervisors not hire another Officer for at least a month, as well as not interview any new applicants. The Chief stated the department is limiting contact with the public, and they do not need a third person. The police department's overtime was discussed is due to a homicide case. If the case goes to trial, Chief Sharkey stated he would rearrange the Officer's work schedule [to prevent overtime].

Jarett Musselman Subdivision: Easement block wording needs to be corrected before the Board signs the subdivision plans.

Setback variance - 827 Bedford Street: On a motion by Jordan Oldham (2nd, Joe Claar), the Supervisors granted a waiver from the Subdivision and Land Development Ordinance Section 505.4 regarding the front setback requirement of 35' to the requested 25'.

Helsel-Clinich Subdivision (Mike & Mackenzie Carrieri): No action Claysburg Area Community Park/DCNR Project: With the assistance of Senator Judy Ward's office, DCED gave clearance for Bramble & Co to finish the playground project.
