

**Greenfield Township Supervisors
Regular Meeting
May 4, 2021**

At the Greenfield Township building, the regular meeting of the Board of Supervisors of Greenfield Township, Blair County, was called to order by Chairman Matt Treon at 6:30 pm. The meeting opened with the pledge of allegiance.

Present: Supervisor Matthew Treon, Supervisor Jordan Oldham, Supervisor Joseph Claar, Eric Casanave (Stiffler McGraw), Chief Ronald Sharkey, Michael Sell (MC Herard via phone), Sally & Robert Barnes, Mike Childers, and Arlene Kuntz.

The Chairman announced the Board had a **Special Public Hearing** at 5:30 pm for the Volunteer Fire Co. Tax Credit Program.

Approval of Meeting Minutes: On a motion by Joe Claar (2nd, Jordan Oldham), the Supervisors approved April 6, 2021, meeting minutes with one spelling correction.
