Special Meeting  
November 10, 2025**

At the Greenfield Township building, the special meeting of the Board of Supervisors of Greenfield Township, Blair County, was called to order by Chairman Jordan Oldham at 4:00 p.m. The meeting opened with the pledge of allegiance.

**RESOLUTION**

**2025-09 DCED Grant** On a motion by Alex Musselman (2<sup>nd</sup>, Michael Childers), the Supervisors approved Resolution 2025-09 to apply for a Statewide Local Share Assessment grant on behalf of the Claysburg Volunteer Fire Company in the amount of \$30,000 to purchase portable radios.

**2025-10 National Fitness Campaign** On a motion by Michael Childers (2<sup>nd</sup>, Jordan Oldham), the Supervisors approved Resolution 2025-10 to accept a \$30,000 National Grant from the NFC Grant Committee and Statewide Partners, and provide a local match of \$145,000 from budgeted funds to promote and implement a free-to-the-public outdoor Fitness Court.

**NEW BUSINESS**

**2026 Budget Work Session:** On a motion by Jordan Oldham (2<sup>nd</sup>, Alex Musselman), the Supervisors voted to have the 2026 tentative budget available November 12, 2025, for public inspection until December 2, 2025, when voted on at the Board of Supervisors meeting.

**Police Department Supplies:** No action taken.

**Highway Department Supplies:** On a motion by Alex Musselman (2<sup>nd</sup>, Michael Childers), the Supervisors voted to purchase tires from Central PA Truck for the Backhoe (\$1,523.98), Ford F350 (\$880.00), Ford F550 (\$780.00) for a total of \$3,183.98.

Roll Call Vote: Jordan, Yes Alex, Yes Michael, Yes

**Invest Remaining Funds into CD:** On a motion by Alex Musselman (2<sup>nd</sup>, Michael Childers), the Supervisors voted to move \$800,000 from the S&T General Funds Money Market and invest in a 12 month S&T Bank CD with a 3.90% interest rate to mature on November 10, 2026.
